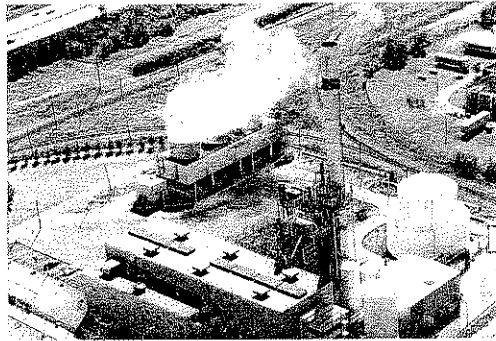

INDUSTRIAL ENVIRONMENTAL COMPLIANCE AWARD



CAMDEN PLANT HOLDING, LLC
Camden Cogen

Camden Plant Holding, LLC (a.k.a. Camden Cogen) is a 145 MW combined cycle power plant located in South Camden, N J. The plant went commercial in March 1993 and provides electricity to the local electric power grid. All water from the site discharges through one of three outfalls processed by Camden County Municipal Utility Authority (CCMUA). Sources of discharge are the plant's blow down lines from its Cooling tower and large waste heat boiler and rainwater. Discharge from the plant's process discharges averages 20,000 gpd on a daily basis, which includes all run and stand-by time, and approximately 60,000-70,000 gpd during periods of full plant operation. Various operational changes have been made over the years to reduce the plants water usage and wastewater flow.
